

The Lima/Allen Co. Chamber of Commerce offers the Remedial Driving Course certified by the West Central Ohio Safety Council & The National Safety Council

This course satisfies the Remedial Driving Course Requirements for license reinstatement by teaching the West Central Ohio Safety Council & National Safety Council Defensive Drive Course (DDC- 6/8)

In order to have driving privileges reinstated an individual may be required to:

- ◆ Complete a remedial driving course
- ◆ File FRA Insurance.
- ◆ Remit any applicable reinstatement fees.
- ◆ Retake a complete driver license examination including the written and road test.

A twelve point suspension results when a driver accumulates 12 points on his/her driving record within a two-year period.

This course also meets the requirements for an individual who wishes to get a 2-point credit.
