



BWC now offers virtual safety training classes. BWC virtual training classes (VTCs) provide an opportunity for students to learn remotely from the convenience of their home or worksite. VTCs are instructor-led classes providing the opportunity for participation and interaction consistent with the comparable BWC in-person class experience. VTCs offer the same continuing education units (CEUs)* and the same BWC program credits as the equivalent in-person class.

System Requirements

- Computer with microphone and speaker set-up utilizing a headset or other low feedback system
- Internet access
- Must download WebEx player before entering training
- Must have a working email address in student's registration account within BWC Learning Center
- iPads, Android tablets, and cell phones have limited functionality and we DO NOT recommend their use for online training

Necessary for a Student Completion

- Sufficient content time in WebEx to match credits assigned to class
- Participation of classroom activities in WebEx
- Completion of online knowledge assessment with passing score within 2 days after class
- Student account at the BWC Learning Center (or LMS). The student account must complete the online knowledge assessment and match the name used to attend the class in WebEx
